Our tribute to former Lord Prior Professor Anthony Mellows OBE TD

It is with great regret that we announce the sad news that Professor Anthony Mellows OBE TD, former Lord Prior 2008 - 2014, died on Sunday 10th January, aged 79.

With a life time career as an academic lawyer, much of it spent as a Professor of Law in the University of London, he was at various times Dean of the Faculty of Law at King's College London and of the University. As a practicing lawyer, he was for many years the senior partner of, and then a consultant to, a law firm in the Inns of Court from which he retired in 2004.

He was heavily involved in a number of other charities such as the Lambeth Fund. In 2003, he was awarded an OBE for services to the Church of England for his work with the Archbishops' Millennium Advisory Group.

Professor Mellows joined the Order of St John in 1980 and was a member of the Council 1981 - 1988. He was made a Great Officer of the Order, first as Chancellor, between 1991 and 1999; then as Deputy Lord Prior between 1999 and 2005; and as Vice-Lord Prior between 2005 and 2008. He was appointed Lord Prior in 2008 and served for 6 years, the maximum term permitted.

Throughout his time as a Great Officer, he was involved in leading the world-wide governing body and setting its strategic direction - he presided over the modernisation of much of the structure and financial organisation of the Order. He was appointed a Bailiff Grand Cross, and for earlier work with the Order in conjunction with the Red Cross, was awarded the British Red Cross Badge of Honour for Distinguished Service.

His contribution to the Most Venerable Order, and to the fraternity of all the Johannine Orders, has been immense: learned, generous and unstintingly given over many, many years.



International Cadet Camp 2016 in Hong Kong



To celebrate the 100th anniversary of St John Ambulance Brigade, the International Cadet Camp 2016 (ICC2016) was hosted in Hong Kong between 2 and 10 January.

Participants came from all St John Establishments worldwide including Australia, Canada, England, Malaysia, New Zealand, Singapore, South Africa, Sri Lanka, Wales, Zimbabwe and Hong Kong. More than 500 officers and cadets enjoyed starting their new year

in Sai Kung, Hong Kong.

The International Cadet Championships was undoubtedly one of the highlights of the Hong Kong ICC2016. A team of 4 cadets representing each contingent competed on abilities in first aid, home nursing, presentation and footdrill.

The New Zealand team successfully defended their championship, winning the St John Worldwide Cadet Competition Shield; while the Australian team took second place, followed by the Canadian team.

What made ICC2016 a remarkable festival among our international St John friends were the opportunities for cultural exchange and building lifelong friendship from all corners of the world.

Hong Kong ICC2016 was a real accomplishment in international collaboration. This success will keep serving as a catalyst for the St John youth development around the world and the development of future international events.

Haemodialysis services expanded across Malaysia



The Haemodialysis Centre of St John Ambulance Malaysia – Selangor Coastal Area (SJAM-KPS) is planning to build haemodialysis centres in rural communities to provide support for people living with kidney disease.

SJAM-KPS chief operating officer, Datuk Yeo Kim Thong said plans were being discussed to set up 3 dialysis centres in rural areas in the next 2 to 3 years.

“We are eager to bring the services to the rural communities to cut down their expenses and travelling time to bigger towns for treatment,” he said.

Caring Pharmacy Group Berhad is continuing with its corporate social responsibility efforts, by contributing RM25,000 to the Haemodialysis Centre of SJAM-KPS.

Managing Director Y.S Chong said the funds were collected from a charity campaign held last year. A small amount from each unit of Good Morning Vplus Nutritious Drink sold contributed to the fund.

Chong, and Good Morning Global Sdn Bhd founder and Chief Executive Officer Datuk Dr Lim Sin Boon said the Haemodialysis Centre SJAM-KPS does a great job in the delivery of these services.

St John Ambulance Malaysia is proud to operate 17 dialysis centres nationwide with more than 230 dialysis machines supporting more than 450 dialysis patients per year.

4 Antiguan row across the Atlantic in support of St John Hospice

The St John Hospice, Antigua, has been extremely proud to be the Charity of Choice for Team Wadadli who has participated in the Talisker Whiskey Atlantic Row Challenge - an extremely challenging 3,000 mile row across the Atlantic from La Gomera, Canary Islands, ending up in Nelson’s Dockyard, Antigua.

They departed on 20 December, encountered a hurricane, survived not only a bout of the flu but debilitating sea sickness, equipment and rudder failure, not to mention having some of their dehydrated food go rotten, to arrive safely in Antigua on 11 February.

The team consisted of Dr Nick Fuller (age 67), Peter Smith (74), Archie Bailey (50) and J.D Hall (29). They have been entered into the Guinness Book of Records for having the oldest man to ever row across the Atlantic and the oldest combined ages.

The Governor General, Sir Rodney Williams who is a Knight of Justice of the Order of St John and Patron of St John Hospice, welcomed the 4 men during a presentation.

So far, Team Wadadli has raised over EC\$250,000 (US\$92,593) for St John Hospice which will assist in running the Hospice.
