About the role

The role of the Service Delivery Officers will be to support our volunteer teams to develop, deliver and measure the core services outlined in the St John Scotland strategy to their local communities.

Main duties and responsibilities

The focus of the 30 hour Service Delivery Officer (PAD & CPR) role will be:

- Supporting the development and delivery of our PAD and Bystander CPR core services at a national level and implementation at Area Level by:
 - Supporting communities to provide Public Access Defibrillators, ordering of equipment and monitoring impact within the community. Engaging with partner organisations to ensure an effective understanding of priority need and impact
 - Coordination of free Bystander CPR and defibrillator awareness training to community groups and the public, including provision of the necessary instructional material and equipment to enable training across the country, which is delivered by local volunteers and partner organisations.
 - Routine liaison with suppliers regarding the purchase and delivery of defibrillators, cabinets and CPR training equipment.
 - Recruitment and retention of CPR Leads and CPR Champions in collaboration with the Volunteer Development Officer.

The focus of the 22.5 hour Service Delivery Officer (PTS & CFR) role will be:

- Supporting the development of our Patient Transport Services to a range of NHS Boards for renal dialysis and oncology patients at Area Level through:
 - Continuation and development of Patient Transport Services in all current Areas.
 - o Development of new services as opportunity and resources permit.
 - Supporting provision of the fleet of St John Scotland PT vehicles, supplemented by volunteers using their own vehicles.
 - Recruitment and retention of coordinators and drivers in collaboration with the Volunteer Development Officer.
 - o Provision of clothing and ancillary equipment.

 Development of a partnership with the Scottish Ambulance Service, seeking to increase St John Scotland's support for Community First Responder groups across the country - such support is principally financial.

Both Service Delivery Officers will:

- Support the development and ongoing work of our Communities of Practice to bring together expertise from across the organisation in order to develop and ensure the sustainability of our services; ensure these are effectively facilitated and promoting good practice across the organisation.
- Produce of data on a quarterly and annual basis to monitor output and progress.
- Ensure that effective governance arrangements are in place for all projects and services at a local and national level in accordance with our objective of being an open and accountable organisation.
- Carry out other duties in support of St John Scotland services, projects and activities as delegated by the Service Development Manager and Chief Executive Officer.

- Working with volunteers in a leadership role within a decentralised organisation to deliver specific outcomes.

- Managing projects, event planning and administration reporting to senior management.
- Experience directly relevant to any of our core services is highly desirable.
- Working within a distributed or remote team desirable

Knowledge and Skills

- Ability to work collaboratively with volunteers, colleagues, and partners to develop and deliver services.
- Knowledge of governance and operational requirements of working within the charity sector.
- An awareness of community health resilience and equalities issues is desirable.
- Holding a First Aid or similar qualification is desirable.
- Excellent IT skills, including experience of using the full Microsoft Office suite with a particular focus on communication within a decentralised organisation.



Personal requirements

- Able to demonstrate a willingness to work alongside volunteers to support them and their activity, to empower others and work collaboratively.
- Highly motivated and resilient. Able to use initiative, demonstrate discretion, sound judgement and effective decision-making ability.
- Excellent communication skills such that you can communicate effectively with people and groups from primary school children to Board Members.
- Commitment to effective remote and hybrid ways of working and meetings.
- Flexibility and adaptability.
- Accuracy and attention to detail.
- Clean UK driving license and a willingness to travel on charitable business and work flexibly to enable effective engagement with our volunteer teams across Scotland. Mileage will be paid, and public transport encouraged, where possible.
